## Victorian Premier flags disability workforce accreditation scheme

Victorian Premier Daniel Andrews told delegates at the ALP State Conference that the Victorian Government would "remain a service provider in some form".

He went on to announce that the Victorian Government "will deliver a legislated registration and accreditation scheme for specialist disability services."

The Victorian Government has since issued a media release entitled, 'Delivering a Fair and High Quality NDIS,' committing to "...establishing an independent, legislated Victorian registration and accreditation scheme for the state's disability workforce."

The media release also makes reference to the Andrews Government remaining a service provider under the NDIS, and that it would "continue to work to genuinely explore options for the continued delivery of public sector disability services."

NDS does not support a Victorian mandatory accreditation scheme. This is not regarded as appropriate for the NDIS environment, particularly as it is a national scheme which is introducing a national quality and safeguards framework. A mandatory accreditation scheme would restrict choice of workers for people with disability. It would also create barriers to workforce supply with the sector competing for workforce with other sectors that do not ask their workers to go through the effort and expense of accreditation. Furthermore, NDIS pricing does not support a stratified workforce.

Rather than a mandatory accreditation scheme, NDS advocates a mandatory national staff screening system. This would play a critical role in a safeguarding framework for disability services. NDS has previously provided advice to the Minister and Department of Premier and Cabinet on the implications of our position on mandatory accreditation.

In light of recent union protests in Victoria about the 'privatisation' of disability services by the State Government, NDS's Victorian State Manager David Moody has been actively advocating for the provision of non-government provided disability services, including via a published letter to the editor of the Herald Sun on 18 October 2016.

NDS will be seeking further clarification on these matters from the Victorian Government as a matter of priority and will provide members with an update on the implications of this announcement shortly.

# Registration Issues

Well over a thousand providers are experiencing delays with their registration application to provide supports under the NDIS.

Most of these are new registrations (i.e., they are from providers not yet working within the NDIS), with a smaller group trying to extend their existing registration to provide new supports.

#### NDIS Failing to Meet Enrolment Targets

A disability advocacy group and the federal opposition claim the National Disability Insurance Scheme (NDIS) is failing to meet its enrolment targets despite reporting a high participant satisfaction rate with the scheme.

The latest quarterly report on the NDIS shows the scheme failed to meet its projected target with just 7,440 participants having an approved plan - far fewer than the first target of 20,264 set for the quarter starting 1 July 2016.

The report showed that the NDIS rollout also failed to meet its revised goal of 10,529 new participants.

"There is a huge gap between the number of people approved and the most recent target," CEO of Disability Advocacy Network Australia (DANA) Mary Mallett told Pro Bono Australia News.

"That number of 7,440 is significantly lower than what we would have expected in the last financial year.

#### Investing in Blockbuster in a Netflix World

Traditional models of employment, management, leadership and service delivery are often expensive, time-consuming, not participant-driven and counter-productive to creating the outcomes that the NDIA wants for clients. At DSC we've seen many different approaches to service design, various ways of cost cutting and methods of utilising technology to achieve organisational goals.

Some of these approaches are fantastic - innovative, flexible, and forward-thinking. Other approaches we've seen haven't been so fantastic they've seemed out of touch, using old data & tools to make new decisions, and focused on shaving cents rather than creating efficiencies. Last week I heard a local politician use the phrase "investing in Blockbuster in a Netflix world" to describe committing money to outdated forms of public infrastructure. This was the best description I've heard for those not-so-fantastic approaches to NDIS readiness and transformation.

The Australian Government is inviting organisations and individuals representing volunteer based community groups to apply for Volunteer Grants 2016 funding.

These grants aim to support the efforts of Australia's volunteers. They provide small amounts of money that organisations and community groups can use to help their volunteers. They are part of the Government's work to support the volunteers who help disadvantaged Australian communities and encourage inclusion of vulnerable people in community life. The funding will help volunteers to do their important work, and the grants of between \$1,000 and \$5,000 each will allow organisations to buy much needed equipment, such as computers, or help with training volunteers, fuel costs or undertaking background security checks.
